I. Call to Order

The meeting was called to order at 8 a.m., by Terri Wolfley, Chair.

II. Call for Agenda Revisions and Approval of Agenda

A **motion** was made by Dana Jones to approve the agenda as revised. The motion was seconded by Dawn Balinski and carried. (All in favor, none opposed)

III. Approval of Minutes from the April 12, 2021, Regular Meeting and Closed Session Meeting

On a **motion** by Dawn Balinski, seconded by Dana Jones, and carried, the Regular Minutes and the Closed Session Minutes from the April 12, 2021, meeting were approved as submitted. (All in favor, none opposed)

IV. Recess, subject to Motion of Privilege for Closed Meeting

On a **motion** by Warren Rice, seconded by Dana Jones and carried, (all in favor, none opposed) the Economic Development Authority (EDA) recessed into closed session at 8:02 a.m., pursuant to General Provisions Article 3-305 of the Annotated Code of Maryland, to discuss three (3) items:

V. Old Business

A. Calvert Industrial Park Property Owners' Association

Robertson-Slagle reported we are actively working with the EDA attorney on the formation of the Property Owners' Association. The attorney is reviewing the property regulations and rules of forming the association. The attorney is also working on a draft letter for the property owners. Once the draft documents are received, they will be shared with EDA for review. Wolfley suggested to share The Patuxent Business Park's Property Owners' Association documentation with the attorney as a reference.

B. Latest Round of Grant Funding

MacAdams reported the *Telework and Online Sales Grant Fund* is offered through our website effective May 10, 2021 9 a.m. and will remain open for a week. The total amount of the grant is \$7,703.07. An EDAC subcommittee will award the grants based on applications.

MacAdams further provided updates on the *Maryland Restaurant Relief Fund* and the *Maryland Hospitality Relief Grants*. The funds provided by the State were allocated, yet more assistance was needed. Robertson-Slagle explained how the County Commissioners and the Finance and Budget Department approved pulling funds from the CARES funds to provide more relief.

C. EDA Legislation/TDRs

Robertson-Slagle reported that Planning and Zoning, along with the TDR subcommittee, will make a follow-up presentation to the BOCC at the May 25, 2021, BOCC meeting.

Public Comment

With no one from the public being present, a call for public comment was not conducted.

Announcements

1. At the April 12, 2021, meeting, four (4) items were discussed in closed session.
2. MacAdams reported an overview of Economic Development week. A website was launched dedicated to the 2021 Economic Development Week. In recognition for their services, a few resource partners will be highlighted throughout the week. Resource partners include the Chamber of Commerce, The Calvert County Minority Business Alliance, Maryland Technology Development Corporation, Southern Maryland Small Business Development Center and Tri-County Council.

- (11) To prepare, administer, or grade a scholastic, licensing, or qualifying examination;
- (12) To conduct or discuss an investigative proceeding on actual or possible criminal conduct;
- (13) To comply with a specific constitutional, statutory, or judicially imposed requirement that prevents public disclosures about a particular proceeding or matter;
- (14) Before a contract is awarded or bids are opened, to discuss a matter directly related to a negotiating strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.
