Public Hearing Set for the Draft Calvert County Comprehensive Plan

PRINCE FREDERICK, Md. – April 22, 2019 – The Calvert County Board of County Commissioners (BOCC) will hold a public hearing Tuesday, April 30 at 7 p.m. to consider and receive comments on the Calvert County Planning Commission's recommended Calvert County Comprehensive Plan (December 2018 Draft). The public hearing will be held at the Calvert Pines Senior Center located at 450 W. Dares Beach Road in Prince Frederick.

If approved by the BOCC, the plan will replace the current Calvert County Comprehensive Plan adopted in 2004 and amended in 2010 and 2017. The BOCC may choose to adopt, amend, remand or disapprove the recommended plan, or consider earlier drafts of the plan.

The initial series of meetings and workshops for the public to provide input began in 2016. County staff held informational meetings, interactive workshops and open houses to receive feedback from residents.
