

A RESOLUTION FOR THE PURPOSE OF SETTING CERTAIN FEES

WHEREAS, Title 1, Subtitle 6; Section 10-323; and Section 12-901 of the *Local Government Article* of the Maryland Annotated Code collectively authorize the Board of County Commissioners of Calvert County, Maryland to, among other things, provide recreational, social, and community amenities;

WHEREAS, the Board of County Commissioners is authorized to establish and levy a regulatory fee associated with the use of such facilities;

WHEREAS, by said authority the Board of County Commissioners of Calvert County, Maryland may fix and collect reasonable service charges or fees from any user of the Edward T. Hall Aquatic Center;

WHEREAS, the Calvert County Department of Parks and Recreation has recommended a fee structure that it purports to be a fair balance of affordability for the users without overwhelming contributions to the facility from the taxpayers of the County;

WHEREAS, the Board of County Commissioners of Calvert County finds that it to be in the best economic interest of the County and its citizens to fix and set the fees for use of the Edward T. Hall Aquatic Center as set forth within Exhibit A hereto, and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that there is and shall be enacted, fixed, and adopt a fee schedule for the Edward T. Hall Aquatic Center as set forth within Exhibit A hereto, which is incorporated herein by reference;

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary and the effective date of any fee change shall be July 1, 2018.
