

**FOR THE PURPOSE OF GRANTING THE CHESAPEAKE RANCH WATER
COMPANY AN EXTENSION OF THEIR WATER SYSTEM FRANCHISE TO
SUPPLY WATER TO A SPECIFIC PROPERTY**

WHEREAS, the Board of County Commissioners of Calvert County, Maryland has authority pursuant to Maryland Annotated Code, Article 25, §3D(b)(2)(i) to grant franchises for the operation of water and sewerage systems; and

WHEREAS, the Board of County Commissioners of Calvert County, Maryland has granted the Chesapeake Ranch Water Company, Inc. assent to exercise the powers of a water company within a specific area pursuant to Maryland Annotated Code, Article 23, §332, subject to reasonable regulations as the Board may prescribe from time to time; and

WHEREAS, The Chesapeake Ranch Water Company, Inc. has requested that the boundaries of the water system franchise area previously granted be further extended to include Lot One (1) of the subdivision known as Romar View, as shown on a plat recorded among the plat records of Calvert County, Maryland at Liber ABE 1, Folio 169, being the same property described in a Deed recorded among the Land Records of Calvert County, Maryland at Liber ABE 310, folio 849; and

WHEREAS, The Board of County Commissioners of Calvert County, Maryland deems it in the public's interest to grant the requested amendment of the franchise area.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Calvert County, Maryland, that the Chesapeake Ranch Water Company is granted assent pursuant to Maryland Annotated Code, Article 23, §332 and authorized to provide water to Lot One (1) of the subdivision known as Romar View as shown on a plat recorded among the plat records of Calvert County, Maryland at Liber ABE 1, Folio 169, being the same property described in a Deed recorded among the Land Records of Calvert County, Maryland at Liber ABE 310, folio 849; and

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of this Resolution shall be enforceable and valid; and

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein.


