**FOR THE PURPOSE OF REPEALING AND READOPTING WITH AMENDMENTS THE
CALVERT COUNTY LAND PRESERVATION, PARKS, AND RECREATION PLAN**

WHEREAS, pursuant to Section 5-905 of the *Natural Resources Article* of the *Maryland Annotated Code*, Calvert County is required to revise its land preservation, parks and recreation plan every five years;

WHEREAS, the Board of County Commissioners of Calvert County, Maryland (the Board of County Commissioners") did repeal and re-adopt the *Calvert County Land Preservation, Parks, and Recreation Plan* by Resolution No. 20-18 adopted on May 15, 2018;

WHEREAS, comprehensive revisions have been proposed to the *Calvert County Land Preservation, Parks, and Recreation Plan* Exhibit "A" hereto and made a part hereof (the "Plan");

WHEREAS, Exhibit A, totaling 224 pages, is not recorded herewith, but is and will be kept on file with the Calvert County Department of Recreation and Parks at its principal office, or at the Maryland State Archives, and is fully and completely incorporated by reference into this Ordinance as though recorded herewith;

WHEREAS, after due notice was provided the State legislators from the district within which any part of the County is located, and published, the Board of County Commissioners and the Calvert County Planning Commission (the "Planning Commission") conducted a joint public hearing on August 23, 2022, at which time the proposed Plan was discussed, staff's recommendations were considered, and public comment was solicited;

WHEREAS, at the conclusion of said public hearing the Planning Commission closed its record and passed a motion regarding the adoption of the *Calvert County Land Preservation, Parks, and Recreation Plan* as submitted by staff and conveyed its recommendation to the Board of County Commissioners by resolution; and

WHEREAS, after considering the staff report, testimony presented at the public hearing regarding the proposal, and the recommendation of the Planning Commission, and in furtherance of the public health, safety and welfare, the Board of County Commissioners of Calvert County, Maryland determined it is in the best interest of the citizens of the County to adopt the *Calvert County Land Preservation, Parks, and Recreation Plan* as set forth in Exhibit A, attached hereto and made a part hereof.

NOW, THEREFORE, BE IT ORDAINED, by the Board of County Commissioners of Calvert County Maryland that the *Calvert County Land Preservation, Parks, and Recreation Plan*, adopted May 15, 2018, being Ordinance No. 20-18, is hereby repealed;

BE IT FURTHER ORDAINED by the Board of County Commissioners that the *Calvert County Land Preservation, Parks, and Recreation Plan*, Exhibit "A" hereto and made a part hereof, is hereby adopted and enacted as the official land preservation, parks and recreation plan for Calvert County, Maryland;

BE IT FURTHER ORDAINED by the Board of County Commissioners that the foregoing recitals be adopted as if fully rewritten herein; and

BE IT FURTHER ORDAINED by the Board of County Commissioners that this Ordinance shall take effect on the date set forth below and publication of a fair summary.






